NOTIFICATION

No.SO(Admn)RR&SD/2-49/2020: In pursuance of the decisions of the NCC in its meeting held on 01.06.2020, and in conjunction with the emergency regarding COVID-19, this Department Notifications issued from time to time, the Government of Khyber Pakhtunkhwa is pleased to order the following:

- i. In continuation to phase-II of the exemption of Construction activities, all remaining businesses, production units and other allied businesses related to construction are hereby exempted from closure subject to the adaptation of SOPs / guidelines already issued for Industrial units and sale points. Moreover, the aforementioned shall remain open for 5 days in a week (if not required to remain open to ensure smooth production cycle) and not later than 7 pm in the day and shall be closed on Saturdays & Sundays.
 - ii. All already identified non-essential shops are hereby allowed to remain open for 5 days in a week but not later than 7 pm in the day subject to adaptation of SOPs. However, these will remain closed on Saturdays & Sundays.
 - iii. All essential businesses, shops, establishment as already identified shall remain open 7 days a week as previously but not later than 7 pm in the day. Pharmacies, Tandoors, Hand Carts (Rehris), Milk shops & supply chain are exempted from closure timings. Take-aways and Home Delivery for Pharmacies, Restaurants including fast food, and Bakeries stand allowed 24/7.
2. The following shall remain **closed till further orders**:
- i. All educational & training institutes including *madaras*.
 - ii. All marriage halls, business centres, Expo Halls etc.
 - iii. All contact sport, indoor Sports Club, indoor Gyms and Sports facilities
 - iv. All indoor and outdoor sporting tournaments
 - v. All Restaurants, Cafés & Hotels for in-house dining, stay.
 - vi. Theme, Amusement Park and Arcades
 - vii. Beauty Parlors and Spas
 - viii. Cinemas and Theatres
 - ix. Public Processions/ Gathering of all Nature / Shrines
 - x. Tourism / Tourist Hotels (Separate exercise to develop SOPs shall be carried out before opening them)
 - xi. All/any activity as per Dist/ Provincial administration's judgement, in areas designated as COVID-19 Hotspots.
