NOTIFICATION

No. SO(Estt)RR&SD/3-5/2019: In pursuance of the declaration of emergency throughout the Province of Khyber Pakhtunkhwa due to Corona Virus (COVID19), vide this Department Notification of even No. dated 3.5.2019 read with powers conferred on the Khyber Pakhtunkhwa Provincial Disaster Management Authority under clauses (c), (g) and (i) of sub-section (2) of Section 16 of the National Disaster Management Authority (Khyber Pakhtunkhwa) Act, 2010, the Authority is pleased to lay down the following **Guidelines for Taking Out People From Quarantine**:

Quarantine Exit Board

There will be a Quarantine Exit Board comprising the Deputy Commissioner, the District Health Officer and a Public Health specialist, which will decide whether a community quarantine of individuals or a locality is further required or is no longer required. In case of such a decision, the individual will be released from Quarantine and put in compulsory home quarantine as a precaution for 14 days and will be checked upon daily for that period.

If the Districts of Quarantine and Residence are different, the Deputy Commissioner ending the quarantine will properly inform the Deputy Commissioner of his/her residence, who will ensure daily checking in on the person for a period of 14 days atleast.

The person as well as close contacts will be properly briefed about precautions and how to ensure safe quarantine as per protocols.

Exit from Quarantine – Individuals

Where individuals are quarantined in a Designated Quarantine Facility the following parameters are suggested for such a decision:

- i. The test of such a person has come out negative through a certified Lab;
- ii. Such a person is not showing any of the symptoms of a suspect case;
- iii. He / she has stayed at the Designated Quarantine Facility for atleast 5 days **after** the test and continues to not show any symptoms;
- iv. The person is voluntarily willing to be placed in home quarantine alongwith the immediate contacts.

2. Guidelines for exit from Community Quarantine will follow.
