The Khyber Pakhtunkhwa PDMA, being the lead focal agency for disaster management and preparedness recognizes the need to formulate the provincial Disaster Risk Reduction Policy in collaboration with stakeholders. The DRR policy for KP PDMA will cater to the needs of provincial climate refugees, recognizing their vulnerability and addressing their specific needs in disaster risk reduction planning; by prioritizing the development of resilient infrastructure and services that can provide climate refugees with access to essential services. The DRR Policy will focus on PDMA capacity-strengthening and community-based interventions, including Early Warning Systems and community-led disaster risk reduction activities.
