



**TENDER NOTICE
HIRING OF RENTAL VEHICLES
PDMA KHYBER PAKHTUNKHWA**

1. Director General, Provincial Disaster Management Authority (PDMA) Civil Secretariat, Peshawar invites sealed bids under National Competitive Bidding from eligible rental vehicles service provider for provision of rental vehicles as per details mentioned in schedule "A" of bidding documents.
2. Bidders must fulfill the following mandatory criteria, In case of non compliance with mandatory criteria bid will be rejected.
 - I. Valid Income Tax Registration Certificate
 - II. Valid General Sales Tax Registration No. (Status Active with FBR)
 - III. Submission of undertaking duly stamped and signed that the firm, company, is not blacklisted or involve in any corrupt or illegal practice or banned or declared ineligible / blacklisted by any procuring agency/KPPRA
 - IV. Bid Security amounting to Rs 100,000/- in shape of CDR in the name of Director General PDMA
 - V. Registration with Khyber Pakhtunkhwa Revenue Authority (KPRA)
3. Bidding shall be conducted through **Single Stage– Single Envelope** Bidding Procedure comprising a single package containing financial proposal as per KPPRA Rules-2014.
4. The nature of contract shall be framework agreement initially for the period of one year as per Rule 31-A of KPPRA Rules ibid wherein the rates at Schedule-A shall be finalized and the bidders shall supply the same as and when needed by the PDMA Authorities over the contract period.
5. Bidding documents, detailed description and quantities of items, can be obtained free of cost from the office of the undersigned during office hours. The Bidding Documents can also be downloaded from official websites of PDMA & KPPRA at www.pdma.gov.pk and www.kppra.gov.pk respectively.
6. The bids shall reach to the Office Assistant Director Procurement PDMA through registered Dak/Courier Services or by hand submission on or before **04.08.2021** at **02:00 PM**. The technical bids will be opened on the same day by the Procurement committee in the presence of Representatives of the bidders who intends to attend at **02:30 PM** in Committee Room of PDMA. Bid received after due date & time shall not be entertained.
7. Financial Bid will be opened after announcement of technical evaluation results. Date, time for financial bid opening will be intimated to technically qualified bidders in written.
8. The bid must be accompanied with Bid Security of Rupees One Hundred Thousand (**Rs.100,000/-**) in the shape of Demand Draft (DD)/Call Deposit Receipt (CDR) in the name of the undersigned.
9. Bids shall be quoted in Pak Rupees and shall inclusive of all taxes where applicable.
10. The undersigned reserves the right to reject any or all the bids as per provisions contained in Rule 47 of KPPRA Procurement Rules 2014.
