

TENDER NOTICE

FRAMEWORK AGREEMENT FOR PROCUREMENT OF RELIEF ITEMS AND FLOOD FIGHTING EQUIPMENTS

1. Director General, Provincial Disaster Management Authority (PDMA), Government of Khyber Pakhtunkhwa, invites sealed bids under National Competitive Bidding from eligible registered firms/manufacturers fulfilling the required criteria mentioned in Bid Solicitation Document for procurement of Relief Items and Flood Fighting Equipment's.
2. Bidding shall be conducted through **Single-Stage Two-Envelope** Bidding Procedure. Each envelope shall contain separately Technical & Financial bid clearly marked in bold & legible letters.
3. The nature of contract shall be framework agreement as per rules 31-A of KPPRA Rules 2014 ibid wherein the agreed rates per item shall be finalized and the bidders shall provide the same as and when required by PDMA authorities over a period of one year (extendable as per rules).
4. Bidders can apply for all or any selective item mentioned in the schedule of requirements.
5. The bid must be accompanied with Bid Security as mentioned in the schedule of requirement (SoR) in the shape of Call Deposit Receipt (CDR) in favor of the Director General PDMA Khyber Pakhtunkhwa. Separate Bid Security shall be submitted for each item.
6. All participating bidders in the tender shall submit 02 No's of samples of each item for evaluation and laboratory testing to PDMA warehouse located at Cherat Road Jalozai District Nowshera on or before **03/07/2024 at 11:30 AM sharp**. Bids without samples will be treated as non-responsive.
7. The samples will be examined by the committee and laboratory tests will be carried out to determine the quality and compliance with the specification. Laboratory testing will be carried out at the cost of bidder. If the samples failed during testing, it shall be rejected straightaway.
8. Successful bidders shall submit performance guarantee @ 10% of the total purchase order after signing contract agreement.
9. Bidding documents, detailed description and quantities of items, can be obtained from the office of the Incharge Procurement Cell, Relief Rehabilitation & Settlement Department, Civil Secretariat Peshawar during office hours till 02/07/2024 COB against Bank Demand Draft of Pak Rupees Three Thousands (Rs. 3000/-PKR) in favor of the DG-PDMA.
10. Pre-Bid Meeting will be held on **27/06/2024 at 11:00 AM**.
11. The bids shall reach to the Office of the Incharge Procurement Cell, Relief Rehabilitation & Settlement Department, Civil Secretariat Peshawar through registered Dak or Courier Services or by hand submission on or before **03/07/2024 at 11:30 Am sharp**. The bids shall be opened on the same day by the Procurement Committee in the presence of representatives of the bidders who chose to attend at **12:00 PM** in the Conference Room of Relief Rehabilitation & Settlement Department, Civil Secretariat Peshawar.
12. Bids received late after due date and time will be treated as non-responsive.
13. Bids shall be quoted in Pak Rupees inclusive of all government taxes where applicable.
14. Bids not fulfilling the bid mandatory / evaluation criteria will be rejected straightaway.
15. Bidders are required to offer most competitive lowest rate of their items inclusive of all the taxes.
16. The undersigned reserves the right to reject any or all the bids as per provisions contained in Rule 47 of KPPRA Procurement Rules 2014
